## REMINDERS



Canton Charter Township, (Wayne Co.), Michigan, Code of Ordinances >> PART I - GENERAL ORDINANCES >> Chapter 46 - OFFENSES AND MISCELLANEOUS PROVISIONS >> ARTICLE IV. - OFFENSES INVOLVING PUBLIC SAFETY >> DIVISION 3. FIREWORKS >>

# SEC. 46-264. DISCHARGE OF NOVELTIES, LOW-IMPACT FIREWORKS AND CONSUMER FIREWORKS.

- (a) Except in the case of a permit issued by the township under section 46-266, consumer fireworks shall not be ignited, discharged, or used by any person at any time, except after 11:00 a.m. on the following dates and times:
- (1) December 31 until 1:00 a.m. on January 1.
- (2) The Saturday and Sunday immediately preceding Memorial Day until 11:45 p.m. on each of those days.
- (3) June 29 to July 4 until 11:45 p.m. on each of those days.
- (4) July 5, if that date is a Friday or Saturday, until 11:45 p.m.
- (5) The Saturday and Sunday immediately preceding Labor Day until 11:45 p.m. on each of those days.
- (b) When permitted, **consumer fireworks shall not be ignited or discharged on public property** [*including our subdivision parks*], school property, church property, or property of another person without that organization's or person's written permission to use consumer fireworks on the premises.
- (c) No fireworks shall be ignited or discharged within 70 feet of any building, or on any public street.
- (d) Minors shall be prohibited from possessing, using, igniting or discharging consumer fireworks.
- (e) No person shall use low-impact or consumer fireworks while under the influence of alcoholic liquor or a controlled substance or both.

Complaints can be called in to the Canton Police at (734) 394-5400, and if you happen to get a license plate number of a specific vehicle, they will add that to the report as well.

#### SAFETY IN THE SUBDIVISION

Summer is here, and with the increase in foot traffic, this is another friendly reminder to our residents who may park their cars on the street or even in the driveway: remove valuables from your vehicle and make sure to lock the car doors. Lock your sheds as well as your houses. Turn on your outdoor house lights at night. With a lack of street lights in our subdivision, turning on house lights surely adds to the safety of our neighborhood.

#### PUBLIC VS PRIVATE PROPERTY

As you continue to enjoy the summer weather and sprucing up your property with new plants or a vegetable garden, please be mindful of the boundaries of your own property and keep these plantings on your property—please do not plant out into the easements or parks. Please do not cut the grass around the park and baseball diamonds. The board has a contracted lawn care company, and our annual dues pay for this work. Thank you to all our residents who take such great care of their yards... Let's let our lawn care company do the rest!

#### **OUTDOOR PETS**

It is a Canton Ordinance that **you must have** control of your pet(s) at **ALL times**. For the safety of your pet **AND our residents**, that means keeping your dog on **YOUR** property and having your dog on a leash when you go for a walk. PLEASE **clean up** after your pets as you go. Canton Twp. Ordinance officers have had many complaints of dog owners not following these requirements, and there is a hefty fine for violators. To report a problem, call the Canton Ordinance Officer for our area, Kay Longton, at (734) 394-5210.

We have residents asking dog walkers who use retracting/long leashes to please use them at the standard leash length

when walking past homes and extend only when walking past the parks.

Residents really DO appreciate your efforts to do the right thing!



In the past, there have been a few lots in Brookside Village subdivision that have had a problem with rats. The BVHA Board would like to offer these reminders to discourage such infestations:

- Sheds should always be built on a concrete slab or be set on a blockfoundation wall.
- Playhouses and pallets are prime spots under which rats may hide.
- Animal feces attract rats, and should be cleaned up regularly and often.
- Garbage, compost, and birdseed should be kept in closed containers.
- Wood and brush piles are possible shelters for rats and should be well kept or discarded completely.

If you lack in the upkeep of your yard, not only are you contributing to this problem, you are in **violation** of your subdivision's Declaration of Covenants, Conditions, and Restrictions, as well as several Canton Ordinances. PLEASE check your yard and make amends ASAP—for the safety of your family, neighbors, and the value of your home!

#### **BVHA Reminder**

It is wonderful to see so many residents out and about and enjoying walking, jogging, riding bikes, roller blading and utilizing both the North and South Park! As part of that, let's be mindful of our residents and their property. Please do not access either Park by walking on and/or through any piece of someone's yard. Each of us can do our part to ensure this kind of action does not continue for those residents affected.
